

To Union Station from NTSB Board Room at L'Enfant Plaza:

Go up the escalator and continue to the end of the hall and turn left to the entrance of the L'Enfant Plaza Metro Station.

Take the Yellow Line toward Fort Totten or the Green Line toward Greenbelt (both lines run on the same track).

Exit at Gallery Place/Chinatown station, change platforms, and take the Red Line toward Glenmont.

Exit at Union Station and proceed to the Train Platforms to Track 7.
